Dear Principal,

In the current climate of economic changes, influenced by explosive knowledge creation and exponential technology growth, the need to modify and infuse changes is a necessary step in the upgradation and updation of the existing Entrepreneurship curriculum. It is even more required so as to bring it at par with the other competency skills based academic disciplines in rigour and content.

The Central Board of Secondary Education has revised the '*Entrepreneurship*' Elective of Class XI, for the session 2013-14. The revised book for class XII will be available in March 2014.

The revised edition of Entrepreneurship incorporates new chapters that introduce students to market dynamics and encourage their latent entrepreneurial skills through project work. The revision aims at providing some more background information, case studies, activities and new templates to help the students attain a better understanding of higher-order concepts that are being dealt with in greater depth in the syllabus of class XII.
